This is to inform that the Ministry of Health & Family Welfare, New Delhi vide its letter dated 05.02.2026, has granted a two year relaxation to those BDS students who were admitted in the year 2015-16 and are currently in their final year of BDS course or in the internship year only. These relaxations are special one-time measure only and Dental Council of India vide its letter No. DCI/Admission/Admsn/BDS/Gen/999/2026-27/2026/10540 dated 23.02.2026, has already conveyed all the concerned stakeholders regarding this decision.

In this regard, the Under-Graduate and Post-Graduate Dental Education Board of National Dental Commission, New Delhi in its meeting held on 24.04.2026, decided to clarify that the effective date for the implementation of this decision shall be the date of the original communication issued by the DCI in this regard i.e. 23.02.2026.
